In this quatitaion shows that the parliement of Royal Family underestimates to women's capability to run business that should be accompanied by men.

Second, there is a third part who wants to take Mia's position to become queen by being replaced by someone else who deserves to be a king in Genovia. Marbey Viscount is Nicholas's uncle. He's believed that Nicholas, the true of Genovia can be the king of Genovia. "(Marbey Viscount) You should be more careful, Your Royal Highness. Somebody might try to take the throne away from you ... somone like me.""(Marbey Viscount) Every time this charming young lady opens her mouth, she demonstrates as a contempt for the customs of Genovia. The law clearly states an unmarried women can not be queen. Fortunately, there is another heir." To achieve his purpose, Marbey Viscount used the Genovian law. He declared that Mia as a single woman cannot be the Queen in Genovia.

4.2 Political Discrimination Reflected in *Princess Diaries 2: Royal Engagement* Movie

The political discriminations Mia experiences are found in some acts. First, the main character has to get married before she takes throne. In the movie, it has been explained with a scene where a woman with the requirements to become a leader or queen must be married. while Mia is not eligible because she is not married. This was denied by Queen Clarrise for reasons that were unfair in Genovian law and treated Mia unfairly."(Queen Clarisse) A man doesn't to marry to be a king, i mean this is the 21st century for heaven's sake."

Second, Mia has arranged marriage. Third, Mia has limited time to get a husband. Fourth, Mia will be replaced as the queen by Nicholas, the born-man Genovian. It is categorized as discriminatory treatment. Discriminatory treatment is increasingly dominating women's lives, many of the women try to show themselves by doing things that are contrary to what society says against woment. As what happen to Mia after she heard that she was given the choice of parliament about 30 days to get married. As Mia said in the citation."(Mia) to have an arranged marriage, or ... that's it, there's no "or" there's i an arranged marriage in my only choice."

4.3 Actions of The Female Character to Gain the Throne in Princess Diaries 2: Royal **Engagement** Movie

The researcher has found the action of female characters to gain the throne in this movie. There are some activities Mia should learn to be a queen. Mia learns to practice all outdoor activities with the traditions of the Genovian Royal Family. starting from learning archery to prepare for the night of ceremony when she later took the throne, and horse riding as a review Royal Guard. As a queen, Clarrise must understand the laws that applied in her country. Mia's grandma asked for the same justice for her granddaughter. She asserted that "a man doesn't have to marry to be king" and she asked that it is also applied to her granddaughter. She thought, in this modern era, women can have the same abilities as men. Women also have the ability to lead. This is proven in the quotation as said by Queen Clarisse."(Queen Clarisse) My granddaughter should be given the same right as any man.".

5. SUGGESTIONS

The writer suggests that the existence of a political discrimination which is currently a problem, should make us human beings who are wiser in acting and treating others right. the political discrimination has taught us that relationship between men and woman has a power that hinders the movement of woman.
